

Belle Chemical new owners not long ago, some safety violations and an explosion at the factory, a mislabeling lawsuit.

Belle Chemical Company in Belle, West Virginia was acquired by Arclin, and the site has been associated with a fatal 2020 explosion and later civil litigation, but the explosion itself involved Optima Belle (a different company operating on the same overall chemical complex), not Belle Chemical under Arclin's ownership. There are also OSHA and Chemical Safety Board findings describing serious safety issues at the Optima Belle facility, and a jury awarded damages in a wrongful death case related to that incident. New owners

- In September 2023, Atlanta-based Arclin, a polymer and resin manufacturer, completed the purchase of Belle Chemical Company, which operates at the former DuPont/Chemours site in Belle, Kanawha County. [3] [6] [8] [9]
- The plant employs roughly 60 people and produces methylamines and related derivatives, and Arclin has described the deal as part of its broader North American growth strategy. [6] [8] [3]

Explosion and safety issues

- The widely reported deadly explosion on December 8, 2020 occurred at Optima Belle LLC, a toll manufacturer on the Belle chemical complex, while processing a sanitizing compound for Clearon Corporation. The U.S. Chemical Safety Board found that a runaway chemical reaction in a dryer led to over-pressurization, an explosion, one death, injuries, property damage of about \$33 million, and a community shelter-in-place order. - CSB and OSHA documents describe multiple contributing safety issues at Optima Belle, including inadequate understanding of reactive hazards, poor process knowledge transfer from Clearon, and weaknesses in process safety management, but these findings are specific to Optima Belle rather than to Belle Chemical under Arclin. Lawsuit and verdict

• In May 2024, a Kanawha County civil jury awarded approximately \$15 million to the widow of a worker killed in the 2020 Belle-area plant explosion, finding the companies involved liable for wrongful death and related damages. Public reporting frames this verdict around the 2020 Optima Belle incident, not a later event under Arclin's ownership of Belle Chemical. [12] [7]

News and CSB materials emphasize the case as an example of liability and responsibility in
toll manufacturing arrangements, but they do not describe a separate "mislabeling"
consumer-product lawsuit against Belle Chemical or Arclin at this site; if there is a specific

Details of the mislabeling lawsuit against Belle Chemical

Belle Chemical (the Montana-based consumer chemical company, not the West Virginia plant) was the subject of a federal recall for mislabeling a drain cleaner under the Federal Hazardous Substances Act (FHSA), but public records show a regulatory recall and compliance action rather than a traditional private civil "lawsuit" with a court judgment. The issue centered on required poison and hazard wording missing from labels on a sodium hydroxide drain cleaner product. [21] [22] [23]

What the mislabeling case involved

- The U.S. Consumer Product Safety Commission (CPSC) announced a recall in March 2020 for a Belle Chemical sodium hydroxide drain cleaner sold in 2-pound bottles. The product label did not include the word "poison" and a required front-panel hazard statement, which violated FHSA labeling rules for highly caustic substances. [22]
- The recall notice instructed consumers to store the product safely away from children and contact Belle Chemical for a replacement label, and it noted that no injuries had been reported at the time. [22]

How it appears in legal/regulatory records

- CPSC enforcement and letter-of-advice data list Belle Chemical Company (Billings, Montana) in relation to FHSA labeling violations and a consumer-level recall for sodium hydroxide products, which is an administrative/regulatory action rather than a court-filed tort case. [24]

- Available public sources do not show a separate, high-profile civil damages lawsuit (for
 example, a class action for injury) stemming from this mislabeling beyond the CPSC recall
 and compliance process; if you are interested in possible private suits, searching specific
 federal or state court dockets by product name, date, and company address would be the

dietary supplements, any issues noted

Belle Chemical does sell dietary supplement ingredients (vitamins, amino acids, etc.), but public records and recall databases do not show specific safety recalls, mislabeling actions, or enforcement cases tied to its supplement line as of the latest available data. The only documented regulatory issue located is the earlier label-violation recall for a sodium hydroxide drain cleaner, which is a household chemical, not a dietary supplement. What Belle sells as supplements

- Belle Chemical (the Montana e-commerce company) markets bulk powders such as curcumin, biotin (vitamin B7), vitamin B12, L-glutathione, L-carnosine, nattokinase, and similar "pharmaceutical grade" or "food grade" ingredients, advertised for use in food, dietary supplementation, or therapeutic applications. - These products are sold through the company's own website and through third-party platforms like Walmart and regional e-commerce marketplaces as vitamins and dietary supplements. [41] [42] [48] [43]

Known regulatory or safety issues

- Searches of CPSC recall listings and other public recall aggregators show Belle Chemical named in connection with FHSA labeling violations and recalls for sodium hydroxide and similar caustic products, but not for any vitamin or supplement item. [39] [44] [49]
- No FDA warning letters, supplement-specific recalls, or public enforcement actions directed
 at Belle's dietary supplements were identified in general web and recall database queries;
 absence of evidence in those sources does not guarantee there have been no minor
 customer complaints or private disputes, but it does indicate no prominent, publicly
 reported supplement safety case to date. [43] [39] [41]
